Mr. Traupman explained to the public the purpose of the Planning Commission stating that no proposed projects were being evaluated at this meeting.

- Review of potential text amendment to zoning ordinance Article VIII Section 185-38
 providing for changes to Employment Districts and Regulations applicable to the AFHBD
 (Aircraft Flight Path Highway Business District)
- Review of potential text amendment to zoning ordinance Article III Section 185-22
 Subsection E related to Traffic Impact Study

Joe Uliana presented the Majestic Hanover Flex Center proposal as it relates to the amended text of zoning ordinance Article VIII Section 185-38. He noted the improvements that the Master Plan Flex Center would provide, including lower density development and reduced traffic as compared to what potentially could be built under the exisiting Ordinance. He stated that the

plan is consistent with the NAZPlan, FutureLV regional plan, Northampton County Freight Based Land Use, and LVIA Area Freight Study.

Public comments primarily centered on noise, traffic, and the amount of warehousing in the Lehigh Valley.

Following a discussion with members of the Planning Committee and comments and concerns noted from the floor, the following motions were made.

Mannix to recommend to the Board of Supervisors that Hanover Township Zoning Ordinance Chapter 185, zoning; Article VIII Employment Districts and Section 185-38 regulations applicable to AFHBD Aircraft Flightpath Highway Business District be adopted as amended.
