**WHEREAS**, Section 203 of the PA Municipalities Planning Code (MPC) (e) The governing body may appoint by resolution at least one but no more than three residents of the municipality to serve as alternate members of the planning commission.

WHEREAS, The term of office of an alternate member shall be four years.

**WHEREAS**, When seated pursuant to the provisions of section 207, an alternate shall be entitled to participate in all proceedings and discussions of the commission to the same and full extent as provided by law for commission members, including, specifically, the right to cast a vote as a voting member during the proceedings, and shall have all the powers and duties set forth in this act and as otherwise provided by law.

**WHEREAS**, Alternates shall not serve as a member of the zoning hearing board or as a zoning officer.


**WHEREAS**, Any alternate may participate in any proceeding or discussion of the commission but shall not be entitled to vote as a member of the commission nor be reimbursed pursuant to section 202 unless designated as a voting alternate member pursuant to section 207.
