Ms. Versteeg shared Pennsylvania's new distracted driving law, 'Paul Miller's Law', which will take effect June 5, 2025. The law prohibits the use of handheld devices while driving, including phones, even at a red light. Drivers caught using a handheld device will receive a warning during the first year (June 2025 to June 2026), but starting June 2026, the driver will face a \$50 fine, plus court costs and fees. This law also includes tablets, portable gaming devices, and other similar devices.

Legal Opinion on Incorporating Trash Fees into Real Estate Taxes

Mr. Prendeville moved the Board to authorize Gross McGinley, L.L.P., to prepare an opinion regarding payment of costs of residential waste & recycling collection contracts in the real estate tax.

Mr. Broughal provided information from the Second Class Township Code and explained there may be some issues if the Township moves forward with incorporating trash fees into real estate taxes and advised the Board to be careful.

Greg Hughes, 856 Merrivale Road, questioned the Board on why they would want to combine the fees and taxes.

Jay Finnigan, 4208 Maria Lane, explained that back in 2000-2008, the Township incorporated the trash fees into real estate taxes and commercial property owners approached him and indicated that if it continued to be in the taxes, they would file a class action lawsuit against the Township to recoup what they've been paying for many years in their taxes. Mr. Finnigan provided information regarding the Second Class Statue Code and stated it isn't in the Township's best interest to incorporate the fees and taxes.

Ms. Lawless clarified that she wants to know what her options are and asked Mr. Broughal to locate the opinion regarding this matter.

Mr. Diacogiannis moved the Board to table the motion until they receive an updated opinion from the Solictor's office.
